### 3.0 Minutes of last meeting

Minutes of the last Parish Council Meeting held on 15<sup>th</sup> May 2023 were agreed and signed as a true record.

### 4.0 Matters Arising

### 4.1 Parking/Lights in Wass

Difficulties continue in trying to get the solar lights programmed in the way Wass wish to operate. We have already tried a test solar light which raised potential concerns over battery life although this might have just been a faulty battery. The cost to test a further unit, programmed to Wass specification is in the region of £500, refundable once the unit is returned.

In view of this further discussions with NYM National Park likely with alternatives being reviewed.

### 5.1 Balance of accounts

# **6.0 Defibrillators**

New pads for the defibrillator in Wass have been purchased.

Regular checks to the defibrillators in Oldstead and Wass need to be undertaken every 2 months to ensure they are available and clean. Condition reports to be sent to Mike Bradley who will update the National Database.

Training on use of defibrillator for Oldstead and Wass residents proposed. Wass Village Hall can be made available most Tuesday or Wednesday evenings.

#### 7.0 Forest England Plans for Oldstead

Logging by Forest England in Oldstead is complete although removal of the cut trees will continue for some time. Complaints on the speed of Contractor's Logging Transport has been discussed with Forest England's Nick Short by Councillor Cain. Some damage to a wall at the junction of Sands Lane by contractors has yet to be discussed with him.

Overall Forest England logging plans appear to have been handled well and the aesthetic result of the work OK.

#### 8.0 Stolen Oldstead Village sign

One of the cast iron Oldstead village signs was stolen around 11th August 2023. A quote for approx. £850 for a replacement has been obtained. Insurance claim to be initiated.

### 9.1 Government Consultation Permitted Development rights for Barns

Following a discussion at the meeting 4 Councillors agreed to support NYM National Parks position with Councillor Skeffington opposing.
